The Company on March 14, 2018, had allotted 1,65,00,000 Convertible Warrants, on preferential basis to Visagar Financial Services Limited (Promoter) at a conversion price of Rs. 1.12/- per warrant (Rs.1/- as face value & Rs. 0.12/- as premium). As per the terms of allotment of the said Warrants read with Chapter V of SEBI ICDR Regulations, 2018 (Chapter VII of SEBI ICDR Regulation, 2009) the Warrant holders were entitled to exercise the right attached to the said Warrants and subscribe to one (1) Equity Share of Rs. 1/- each against each Warrant, within a period of Eighteen (18) months from the date of allotment of such Warrants, i.e. on or before September 13, 2019. However Visagar Financial Services Limited have failed to convert the same within the stipulated time period. Therefore the warrants stands forfeited. Also to inform you that the holding of Visagar Financial Services Limited is NIL. So we have not mentioned its name in previous quarter report. But in the previous quarter we have received query from NSE that we should mentioned the name of Visagar Financial Services Limited as promoter with NIL holding. Therefore, we have mentioned its name in this quarter report with NIL holding. Kindly consider the same for this quarter and previous quarter as well. Please take note of the same.
